

## Parking rules at TU Darmstadt

### § 1 Fundamentals

(1) These parking rules only apply to parking areas of TU Darmstadt separated by barrier systems, bollards or similar. These parking areas are the property of the state of Hesse and are maintained independently by TU Darmstadt in accordance with §4 (2) TU Darmstadt law.

(2) Entry into parking areas in accordance with para. (1) including the use of parking spaces is only permitted for

- a. persons who hold a valid personal parking permit,
- b. university vehicles that hold a valid parking permit,
- c. special vehicles (e.g. emergency services, fire brigade, police, disaster control, waste disposal) and
- d. third parties (e.g. guests, assigned companies) who have been granted short-term special authorisation by staff of TU Darmstadt or their vicarious agents via remote opening of the barriers.

(3) The parking rules do not apply

- a. on public roads and in areas subject to public order by the road authorities and
- b. to rented parking spaces. The respectively agreed regulations apply there.

### § 2 Validity of StVO

For the parking areas in accordance with §1 (1) , the general statutory provisions (road transport law, road traffic regulations, criminal code, etc.) also apply.

### § 3 Parking

(1) The parking of vehicles is only permitted in the parking areas provided and indicated accordingly.

(2) In particular, the following is **not** permitted:

- a. The parking of vehicles in entries, building entrances, on fire brigade access routes, parking and access areas for emergency vehicles and directly in front of fire escapes, exits and emergency exits,
- b. the parking of vehicles in disabled spaces without a valid permit,
- c. the parking of deregistered vehicles and scrap vehicles,
- d. the repairing and cleaning of vehicles, in particular where these are associated with soiling of the parking area or noise pollution,
- e. camping or overnight stays.

#### **§ 4 Supervision and infringements**

- (1) The supervision of parking areas in accordance with §1 (1) is undertaken by authorised employees of TU Darmstadt. Their instructions are to be followed.
- (2) Illegally parked vehicles are towed away for a fee. TU Darmstadt reserves the right to withdraw a parking permit in the case of repeated infringement against the parking rules.
- (3) The barrier systems are under video surveillance to control entries and exits, monitor functionality and to verify damage to property.
- (4) The time and duration of parking are recorded and saved for statistical evaluations without any allocation to a vehicle or owner.
- (5) The vehicle registrations and entry and exit times are recorded for guests who are granted short-term special authorisation via remote opening of barriers.


#### **§ 5 Disclaimer**

- (1) The parking areas are used at your own risk. TU Darmstadt assumes no liability for personal injury, property damage or financial losses – in particular for damage, break-in or theft of the motor vehicle and for damage arising when moving or towing unauthorised and/or incorrectly parked vehicles – unless the damage results from wilful or grossly negligent conduct of TU Darmstadt or its vicarious agents. Compensation claims among users or towards third parties are governed by the provisions of civil law.
- (2) TU Darmstadt is not obliged to guard parked vehicles.
- (3) Liability for public safety in the car parks is assumed in the statutory scope.

#### **§ 6 Entry into force**

These parking rules enter into force on 1st October 2013.
